### About the Award

The Australasian Institute of Mining and Metallurgy (the AusIMM), Environment Institute of Australia and New Zealand (EIANZ) and BHP have come together to offer financial support under the Social and Environment Student award (the Award).

The purpose of the award is to provide financial support to students interested in pursuing a career in the environment and/or community disciplines within the minerals industry. The award is valued at up to \$3,000 and is intended to offset financial expenses directly related with completion of an Honours or Masters research project, or equivalent.

To be eligible for the award, you must be a currently enrolled student planning to undertake an accepted Honours, Masters or PhD research topic with an environment or community focus within the minerals industry.
